#### Life Verification

Since the death of a benefit recipient is not always reported to the system by a family member or captured by the system's extensive death audit process, it is important a life verification process is implemented to ensure erroneous benefits are not being paid to a deceased individual.

Staff is tasked with ensuring benefits are only paid during the time allowed by law, and only to those that are legally entitled to the benefits. Protecting the retirement system from errant payments or theft of benefits requires a collective effort from LOPFI staff and all benefit recipients. The timely notification to LOPFI regarding the death of a benefit recipient ensures their benefit payment can be stopped and that any survivor benefits due can be paid without delay.

LOPFI is anticipating rolling out a Life Verification process later this year. The concept is for LOPFI to communicate with a specific number of benefit recipients each year to validate the person is still living and confirm the contact information on file is correct. The benefit recipient will be provided with a form that will have them provide their signature, confirm/update their contact information, and have the form notarized.

### **Attention Employers**

As a LOPFI-covered department you are required to enroll any employee working in a LOPFI-covered position as of the date their employment begins. This means, employers cannot legally delay LOPFI enrollment for any period of probation.

LOPFI Board Rule #15 defines a police officer as any paid or volunteer Member of a police department of a political subdivision who is recognized as a law enforcement officer by the Commission on Law Enforcement Standards and Training and is responsible for the prevention and detection of crime and the enforcement of the criminal, traffic, or highway laws of this State. *This definition shall include probationary police officers and legally appointed auxiliary officers*.

LOPFI Board Rule #15 defines a firefighter as any paid or volunteer Member of a fire department of a political subdivision that is certified by the Arkansas Fire Protection Services Board and engages in training, inspection, fire suppression, rescue, or other fire-ground activities. *This definition shall include probationary firefighters*.

Remember, LOPFI classifies a paid Member as someone whose gross monthly wages meet or exceed the minimum threshold amount on a regular and recurring basis. Volunteer Members are employees whose gross monthly wages do NOT meet or exceed the minimum threshold amount. The 2024 monthly minimum threshold amount is \$1,771.00 and was provided to employers in November of 2023.

### Financial Update

What a difference a year makes! While 2022 was a tough year for investments, 2023 rebounded and generated a healthy 15.90% net return for the LOPFI portfolio. A result of that performance is the assets moved back above \$3 billion. At the close of December 31, 2023, LOPFI's market value was \$3.157 billion; an increase from \$2.740 billion at the first of the year.

As a Member of LOPFI, you are encouraged to remain current with the activities of the retirement system. Please:

- ✓ Attend meetings of the Board of Trustees. Meetings typically have a Zoom link on the agenda that offers you the ability to know what is happening from the convenience of your office or home.
- Continually monitor your record via the Member Portal to ensure all information remains correct. And activate multi-factor authentication for added security if you have not already done so.

- ✓ Read the PensioNews.
- ✓ Review the Member Handbook.
